# Temporary Firearms Storage Program Agreement (Background Check Required upon Return of Firearms)

This Agreement is hereby made and entered into as of the date set forth below, by and between the undersigned customer ("Temporary Storage Customer") and \_\_\_\_\_\_ (Retailer) .

All storage decisions are at the sole discretion of \_\_\_\_\_\_ (Retailer) ownership/management. \_\_\_\_\_\_ (Retailer) is in no way required to agree to store a firearm and may terminate this agreement at any time for any reason, resulting in the firearm being returned to the owner, per the provisions set forth below. The process for the intake of temporary storage firearms is as follows:

- \_\_\_\_\_ (Retailer) will evaluate the temporary storage prospect and make a determination regarding storage in its sole discretion.
- \_\_\_\_\_ (Retailer) *will not* accept temporary storage firearms that do not comply with all applicable laws (city, county, state and/or federal).
- ALL temporary storage firearms must be in a case or other firearms/range bag.
- \_\_\_\_\_ (Retailer) *will not* accept National Firearms Act ("NFA") items (suppressors, short barreled rifles, etc.) for temporary storage.
- <u>All temporary storage firearms are subject to a \$25 processing fee and a \$50 storage fee for the first</u> <u>firearm, and a \$10 storage fee for each additional firearm. All fees must be paid before the firearms</u> <u>are accepted for storage.</u>
- All temporary storage agreements are for a maximum of 90 days. NO EXCEPTIONS.
- All Temporary Storage Customers must be present at the \_\_\_\_\_\_ (Retailer) facility and must produce a valid and current Driver's License or Passport (which will be copied and filed with this agreement) containing current contact information.
- All returns of any stored firearms MUST be to the undersigned Temporary Storage Customer ONLY (or to a legally appointed representative, in the case of death or other legal incapacitation of Temporary Storage Customer legal documentation required).
- Upon the return of a firearm to the Temporary Storage Customer, he or she will be subject to all
  applicable firearms requirements and regulations (city, county, state and/or federal) with respect to
  the sale and/or transfer of firearms, including being required to pass any relevant background checks,
  and pay any applicable fees.

## Temporary Firearms Storage Program Agreement Continued (Background Check Required Upon Return of Firearms)

- In the event that the Temporary Storage Customer fails the required background check, or is in any other way disqualified under applicable law from possessing a firearm, or fails to pick up the firearm(s) within 6 months after being contacted by \_\_\_\_\_\_\_\_\_ (Retailer), the firearm(s) shall become the property of \_\_\_\_\_\_\_\_\_ (Retailer), and may be disposed of at the sole discretion of (Retailer).
- Temporary Storage Customer may terminate this Agreement at any time upon written notice. In the event of such termination, Temporary Storage Customer MUST retrieve any stored firearm(s) within 5 days of \_\_\_\_\_\_\_ (Retailer)'s receipt of said termination notice. As stated above, Temporary Storage Customer will be subject to all applicable laws, requirements and/or regulations related to the sale or transfer of firearms, including relevant background check(s) and fees.

By signing below, Temporary Storage Customer acknowledges that he or she has read, understands, and will abide by all of the terms, provisions and conditions of this Temporary Firearms Storage Agreement. Temporary Storage Customer hereby certifies that he or she is the legal and rightful owner of any temporary storage firearm(s) listed on <u>Schedule A</u> attached hereto and made a part hereof, and is permitted to own and possess said firearm(s) pursuant to all applicable laws (city, county, state and/or federal).
